**Subject:** KBFRFCHA planning process change- PWC regulation

Hello All,

I wanted to give you (the planning team) a head's up on an impending change to the KBFRFCHA plan revision process –

The governor's office has decided to repeal the PWC prohibition for Kachemak Bay and Fox River Flats CHAs (5 AAC 95.310 Personal watercraft use prohibited). This change will be conducted as a stand-alone regulation change pursuant to the Administrative Procedures Act, and will be done independently of the ongoing plan revision.

The future draft of the KBFRFCHA management plan revision will not have a Personal Water Craft Policy. I do appreciate the time you invested in discussing the issue in the planning team meetings.

A public notice will be posted and published when a comment period for the regulation repeal opens. The contact info of commenters from the KBFRFCHA public scoping process will be made available to be included in the "interested parties" distribution list. The public notice will contain the information on the comment period timing and how to submit comments to Rick Green, who will be the department's point of contact on the repeal.
