Ms. Haas:

In a letter dated January 26, 2021, you requested the following public records from the Alaska Department of Fish and Game (ADF&G):

- 1) All communications between the Personal Watercraft Club of Alaska and the Alaska Department of Fish and Game (ADF&G) as well as all communications between the Alaska Outdoor Council and ADF&G.
- 2) All documents of internal statements of policy, interpretations to staff, formal or binding opinions, and factual statements from the Commissioner or the Special Assistant to the Commissioner to ADF&G staff regarding Personal Watercraft, including the order that prohibited or restricted ADF&G staff from communicating with the public about the repeal of 5 AAC 95.310, and directed staff to tell all members of the public to speak only to Rick Green about the repeal of 5 AAC 95.310.

Regarding the first part of your request, we searched the emails of Ron Benkert, Rick Green, and Doug Vincent-Lang for responsive records. We did not search other ADF&G staff who we believe would not have responsive records or would only have duplicative records. Any other responsive records not attached here were delivered to you on January 14, 2021 and December 17, 2020, respectively. Please let us know if you would like us to provide those records again; however, public comments received from those and other organizations are available on ADF&G's website.

Regarding the second part of your request, ADF&G did not issue an order that prohibited or restricted ADF&G staff from communicating with the public about the repeal of 5 AAC 95.310; however, the attached internal communications plan names Rick Green as ADF&G's communication coordinator for the regulatory proposal. Please confirm that is the document you were requesting.

Thank you for your recent correspondence regarding the management plans that affect Kachemak Bay State Park and Kachemak Bay and Fox River Flats Critical Habitat Areas.

Alaska Department of Fish and Game (ADF&G) and the Department of Natural Resources (DNR) / Division of Parks and Outdoor Recreation (DPOR) share jurisdiction over the portions of Kachemak Bay where the State Park and the Kachemak Bay Critical Habitat Area overlap. Though coordination efforts are in place, each agency implements their authority in accordance with their individual management responsibilities. Both agencies have undertaken revisions to their existing management plans that include public comment periods and this correspondence is intended provide you with an update to the progress of DNR's Kachemak Bay State Park management plan revision and ADF&G's Kachemak Bay Critical Habitat Area management plan revision.

DNR is currently drafting the Kachemak Bay State Park Management Plan and intends to release it for public comment this summer. Recognizing that the summer is a busy time for stakeholders, the department is planning on taking public comment on the plan for an extended period.

The Department of Fish and Game's public scoping process was complete November 2016. ADF&G has published the public scoping comments on the <u>Kachemak Bay and Fox River Flats Critical Habitat Areas Management Planning webpage</u> and you are welcome to review the comments received related to personal watercraft, as well as other information about the process. Comments received during scoping are incorporated in the information reviewed by the multi-agency planning team that is developing draft policies. ADF&G has decided to incorporate the regulation pertaining to the ban on personal watercraft in Kachemak Bay CHA (5 ACC 95.310) in the plan revision process.

The Critical Habitat Areas management plan's multi-agency planning team continues to meet to work on the draft revision. These meetings are open for members of the public to observe for maintaining transparency in the plan revision process; there will not be opportunities for the public to participate in the discussion. A public review of the draft revised plan will be available for public comment at the end of the revision period. We hope to have the public review draft revised plan published for comments in 2019.

Hi Rick.

It has been a couple of weeks or more since I had the pleasure of meeting you and speaking with you in Fairbanks. Since that time I briefly met Ricky Gease with State Parks. I'm actually on the Alaska Boating Safety Advisory Board (ABSAC) which meets in April and December. Ricky attended the meeting on the 8th and during a break I asked him about the status of the KB management plan. He stated there was going to be another public comment period open to the public once they finalize their draft of the plan. I haven't seen anything on the website to date. When I mentioned personal watercraft he said as far as he could tell there weren't going to be any changes from what the statutes say now. He said Monica Alverez is the person to contact (which we've done in the past with our letters) when it's time for public comments again.

At this point I think letter writing to anyone is a mute point although we will once again when the public comment period is open. It hasn't done us any good in the past no matter how many people write, they always say the public voted for the ban. That is so not true and I want to see actual numbers that say something out of x many comments received y stated they want to keep a pwc ban in the bay. (I have the original numbers from 1999-2000 but not with me and it was only like 420 comments about pwc.) Anyways, I think the most important thing right now is the difference of the areas managed by DNR and ADF&G. There is no reason ADF&G can't open the main part of the bay with simple restrictions in the areas of the state parks. I don't think it's right or fair really because we should be able to go where all boats go but at this time in the game if we need to compromise to at least have access to public launch ramps in Homer to enjoy the bay and be able to go to Seldovia and beyond is the most important thing.

Is there any way you can arrange a meeting with the Directors involved in this planning process and be present as well along with a couple members of PWCA and the industry representatives to talk about this compromise and what we need to do to gain access.

Looking at the attached map just infuriates me that a specific type of boat is banned from the bay.

This is a follow up letter to the one I wrote February 25<sup>th</sup> regarding personal watercraft use in Kachemak Bay. I am disappointed that I have not heard anything back from the Office of the Governor as I had copied it directly to the Governor as well writing one directly to the Governor March 7<sup>th</sup>.

I am again requesting that the administrative codes: 5AAC.95.310, 11AAC20.115 and 11AAC20.215 be repealed because these regulations were adopted into policy in 2001 based on anecdotal evidence and biased opinions regarding the use of personal watercraft.

My concern regarding these codes is the fact that ADNR and ADF&G plan to include them in the revisions and updates to the Kachemak Bay & Fox River Flats Critical Habitat Area Management Plan. Wednesday May 22, 2019 the seventeenth planning team held a meeting to continue discussing the draft policies and provide transparency to the public. While it was not a meeting for public testimony only observation any public in attendance was allotted time to ask a couple of questions. As the Director of the Personal Watercraft Club of Alaska (PWCA) I was not able to attend the meeting myself but had 3 other representatives of the club and the industry present. After sitting through the presentation Korey Cronquist, owner of Team CC Wasilla asked why was the ban going to be included in the management plan. The answer was because the habitat values are not met with that user group. At that time Korey did not ask any further questions because he knew it wasn't the time to go in to detail, however he sent a follow up email to Tammy Massie the following day. I have included his email and Tammy's response. PWCA president Gene Gerken sent a follow up email regarding the same topic and got the basic same reply, which I have included as well.

The main thing I have been emphasizing for 20 years, is this ban is based purely on discrimination, biased opinions and unscientific evidence. Tammy's current response to both Gene and Korey state, "the management plan policies are based on activities, not on user groups." I find this not to be true because personal watercraft are boats, pure and simple and the activity is boating, fishing, sightseeing just like other 'boaters' using the bay. So, if her statement was true than we wouldn't be having this ongoing battle for 20 years and personal watercraft would be allowed in the bay.

Tammy's last paragraph in the response letter to Gene states there are several layers of internal review that need to occur before the public review draft is ready for release. Our request at this time is that the Governor repeal the codes mentioned earlier and take them out of the new draft management plan completely. Kachemak Bay is 220,000 acres of water that all boaters should have equal access to. If

there are a few coves, critical nesting ground areas or other small areas of concern, then all boaters should be banned from those specific areas, not the entire navigable waters for the bay and waters included in the Alaska Marine Highway.

John Sturgeon, whom I know you are familiar with recently won his battle about discrimination by the federal government when he used his airboat on navigable waters. The U.S Supreme Court voted 9-0 that Alaska is different and Alaska manages their own navigable waters, not the National Park Service (other outside government agency). With this said, I am hoping Alaska's legislatures and the Governor manage our navigable waters appropriately and without discrimination to a specific user group or type of boat. We all want to believe that this Supreme Court win means we can trust the State to manage wisely.

"Shavelson said this (allowing PWC) adds up to safety concerns, threats to wildlife and a major change to the *feel and culture* of the Kachemak Bay area as it's currently known and enjoyed."

This gets back to the "Not in my backyard" (NIMBY) syndrome running rampant in Alaska. (Never mind that it's not just "their" backyard.)





## SCI Praises Proposed National Park Service Rule Implementing Sturgeon Supreme Court Decision

Washington, DC - April 30, 2020 - Safari Club International (SCI) praises the proposal published today by the National Park Service (NPS) to amend NPS regulations applicable to Alaska. The proposed rule implements the U.S. Supreme Court decision in *Sturgeon v. Frost*, a case brought by SCI Life Member John Sturgeon.

Sturgeon was cited by the NPS after using his hovercraft in the Yukon-Charley Rivers National Preserve in Alaska to get to his favorite moose-hunting location. He challenged an NPS regulation prohibiting use of hovercrafts on rivers flowing through NPS lands on the ground that it did not apply to Alaska.

The case went to the Supreme Court twice. SCI filed a trio of amicus briefs in support of Sturgeon's position.

The Supreme Court held that the NPS lacks authority to regulate non-federal lands, even those located within National Park and Preserve borders, under the Alaska National Interest Lands Conservation Act of 1980 (ANILCA). The NPS may only regulate federally-owned lands in the National Park System. Because the State of Alaska owns the submerged lands under navigable waters in Alaska, the NPS cannot regulate those waterways. Under the Supreme Court's opinion, Sturgeon could "again rev up his hovercraft in search of moose."

Today's proposed rules were published in response to a petition by the State of Alaska. They revise the "Scope and Applicability" of NPS regulations to clarify that they do not apply to non-federally owned waterways in Alaska. The proposal also carves out non-public lands from falling within the boundaries of National Park System units in Alaska.

"Safari Club appreciates that the proposed NPS rules remain true to the Supreme Court's decision," said SCI CEO W. Laird Hamberlin. "The Supreme Court did more than tell the NPS to allow hovercrafts. The Court made clear that ANILCA restricts where the NPS can regulate to federal lands in Alaska. This ensures the proper balance of State and federal authority, and benefits hunters by reducing the restrictions applicable to non-federal lands."
